

BY THE COMMISSION:

12 Having considered the entire record herein and being fully advised in the premises, the
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

14 1. Troy Billiards, Inc. ("Applicant") has a Certificate of Convenience and Necessity
15 ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona
16 pursuant to Decision No. 59272 (September 20, 1995).

17 2. On September 20, 2000, Applicant filed with Docket Control of the Commission an
18 application for approval of the sale of assets and cancellation of the Certificate, indicating that it no
19 longer provides COPT service in the State of Arizona.

20 3. In Decision No. 55817 (December 10, 1987), the Commission found that COPT
21 providers were public service corporations subject to the jurisdiction of the Commission.

22 4. Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to
23 regulate COPT providers.

24 5. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes
25 rates and minimum service standards applicable to COPT service.
