12 **BY THE COMMISSION:**

13 Having considered the entire record herein and being fully advised in the premises, the
14 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

15 **FINDINGS OF FACT**

16 1. Robert L. Gaefcke dba B S Communications ("Applicant") has a Certificate of
17 Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT")
18 service in the State of Arizona pursuant to Decision No. 60196 (May 16, 1997).

19 2. On November 9, 1999, Applicant filed an application for approval of the cancellation
20 of the Certificate.

21 3. In Decision No. 55817 (December 10, 1987), the Commission found that COPT
22 providers were public service corporations subject to the jurisdiction of the Commission.

23 4. Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to
24 regulate COPT providers.

25 5. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes
26 rates and minimum service standards applicable to COPT service.

27 6. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT
28 Certificates without a hearing.
