On June 27, 2003, the Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission"), an application for a rate increase and for approval of purchased power contract.

On November 3, 2003, Southwestern Power Group II, LLC and Bowie Power Station, LLC filed a request to intervene and Mesquite Power, LLC filed a request to intervene.

On November 6, 2003, pursuant to Rule 33(c) and (d) of the Rules of the Supreme Court, S. 
