14 **APPLICATION OF PANDA GILA RIVER, L.P. FOR LEAVE TO INTERVENE**

16 Pursuant to A.A.C. R14-3-105, Panda Gila River, L.P. ("Gila River") hereby applies to
17 the Arizona Corporation Commission (the "Commission") for an order granting Gila River leave
18 to intervene in the above-captioned proceeding. Gila River owns and operates a 2080-megawatt
19 power plant near Gila Bend, Arizona. As a result of the Commission's recent Track B solicitation
20 process, Gila River has obtained, among other things, certain contracts during non-summer
21 months to provide wholesale power to Arizona Public Service Company ("APS"). Additionally,
22 Gila River provides APS and other Arizona load serving entities with wholesale power during
23 times of peak demand. As a supplier of electricity in Arizona's wholesale competitive market,
24 Gila River will be directly affected by the decision of the Commission in these proceedings.

25 Gila River's participation in these proceedings will not broaden the issues or unduly delay a
26 decision by the Commission on the merits of the application. For the foregoing reasons, Gila River


1 respectfully requests that the Commission grant its Application for Leave to Intervene in this matter.


