
The Federal Executive Agencies (FEA), by and through the undersigned counsel of the Air Force Utility Litigation Team, wish to intervene in the application for increases in the Electric Rates and Charges filed by Arizona Public Service Company (APS) on June 27, 2003. The FEA consist of certain agencies of the United States Government which have offices, facilities, and/or installations in the service area of APS and which offices, facilities, and/or installations purchase electric utility service from APS. The Department of Defense (DoD) has been delegated authority by the General Services Administration to represent, through Department of the Air Force counsel, the consumer interest of the FEA in this proceeding under 40 U.S.C.A. 481(a)(4) and 486(d).

Chief among the Federal customers in APS' service area, in terms of load, are the DoD installations Luke Air Force Base and Yuma Marine Corps Air Station. Electricity costs represent one of the largest variable expenses of operating the Federal offices, facilities, and/or installations on whose behalf intervention is sought herein, and all will be significantly affected by any action this Commission takes in this Docket. For these reasons set forth, we submit the FEA have a substantial interest in the proceedings in this Docket and request the Commission grant the FEA party status.

This intervention is sought by the FEA solely in their proprietary capacity as customers of APS, and not in the sovereign capacity of the United States Government. The counsel filing this motion is the duly authorized representative of the FEA in APS' electric service area.
