PROCEDURAL ORDER

**BY THE COMMISSION:**

On June 27, 2003, the Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase and for approval of purchased power contract.

On July 25, 2003, the Utilities Division Staff ("Staff") of the Commission filed a letter stating that the application was found sufficient and classified the applicant as a Class A utility.

On January 22, 2004, pursuant to Rule 33(c) and (d) of the Rules of the Supreme Court, Jay Moyes, on behalf of PPL Energy Plus, LLC and PPL Southwest Generation Holdings, filed a Motion and Consent of Local Counsel for admission of Jesse A. Dillon for pro hac vice in the above-captioned matter. The Consent listed Jay I. Moyes, as the designated member of the State Bar with whom communication can be made and upon whom papers shall be served.

In the discretion of the Commission, Jesse A. Dillon should be permitted to appear and participate in the above-captioned matter.


