

**Re: Desert Hills Water Quality**

Dear Commissioner Mundell:

As you know, Arizona American Water provides water service to Desert Hills, an unincorporated portion of Mohave County near Lake Havasu City. Our Desert Hills service area is relatively small, serving 1,250 households with 3 wells and a three small primary booster stations. Water quality in the system has consistently met all regulatory requirements for many years.

On February 13, 2004, regular water quality tests showed that nitrates levels in a portion of the Desert Hills system were 12 mg/l. This was the first time that nitrates above the nitrate standard or maximum contaminant level (MCL) of 10 mg/l were detected. Previous measurement of nitrates ranged from 6mg/l to 8mg/l.

Arizona American recognizes that nitrates in drinking water are a serious concern for infants less than six months old. Considering that we received the test results late in the day on a Friday before a Holiday weekend, we were especially concerned about providing adequate notice to our customers. As a result, we determined the fastest and most thorough public notice would be paid radio advertising. We augmented this with a press release and a bill insert. While this far exceeds our regulatory requirement, we thought the combination of short-term tactics (paid radio advertising) with the long-term educational component of a bill insert would be a powerful combination.

I have attached copies of the following items:

- Radio ad run schedule
- Customer bill insert
- Press release

During this time, our staff has been in contact with Marlin Scott Jr, and Janie Woller on the ACC staff to keep them apprised of our progress in notifying the public. Throughout this time we have made bottled water available to all of our customers at no charge. In addition Arizona American Water has implemented a plan to

supplement the water supply in Desert Hills. The plan involves the accelerated addition of a new well and booster station and construction of 1,000 feet of 10-inch diameter interconnection pipeline. The pipeline will connect the new well and booster station to the existing portion of the Desert Hills system experiencing high nitrates. With the addition of the new water supply, all of the Desert Hills system will again meet all water quality standards.

We have prioritized this project and have both our engineering and operations staffs working diligently on completing the well and pipeline. We expect the project to be fully operational not later than the end of April. Let me assure you that we are doing everything possible to expedite this project and provide drinking water to our customers meeting all regulatory standards at the earliest possible date.

I hope this information is helpful to you in better understanding the nitrate situation in Desert Hills and our public notification and remediation efforts we have undertaken as a result. We will continue to communicate with our customers over the next few weeks while we work diligently to eliminate the nitrate problem.

30-second radio announcement:

Desert Hills area customer of Arizona American Water should take note. Recent water tests have revealed 12 milligrams per liter of nitrates. The national standard is 10 milligrams per liter. Infants less than six months who drink water containing nitrate in excess of the MCL could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome. Tap water should not be used for mixing infant formula or juices. Nitrates in drinking water can come from a number of sources, including septic tanks. Only infants less than six months old are affected by this notice. 



### About Nitrates in Your Water

At Arizona American Water, water quality is our number one commitment. We constantly monitor water quality, conducting hundreds of tests each year to measure and maintain the quality of the water we send to your home. Arizona American Water regularly samples the water quality in your water system. We do this to make sure your water meets or exceeds U.S. Environmental Protection Agency and Arizona Department of Environmental Quality (ADEQ) regulations. Each year, we do a comprehensive report of our test results, called the Annual Water Quality Report or Consumer Confidence Report. Look for this report in your mailbox in early June.

In a recent routine sampling on February 13, 2004, water sample results showed that nitrate levels in the area were 12 mg/l, which exceed the maximum nitrate standard of 10 mg/l. Although this is only two parts per million over the standard, high nitrates can be dangerous to infants. Nitrates in drinking water are a serious concern for infants less than six months old. Because of the possible danger, we immediately notified the public through radio and newspaper announcements. As a result of this exceedance, you should not give tap water to infants under six months, or use it to make infant formula.

### The cause for excess nitrate levels

Nitrates in drinking water can come from natural, industrial or agricultural sources, including septic systems. In 1997, ADEQ believed septic system discharge to be the largest contributor to groundwater quality deterioration when elevated nitrogen levels were found in wells throughout the City of Lake Havasu. Levels can vary throughout the year, and it is not now known when nitrates may reduce to levels safe for infants.

### How we are correcting this problem for the future

Nitrates in low concentration are not a problem for anyone, including infants. To prevent future nitrate levels that exceed safe standards, Arizona American Water will

be building a new pipeline to dilute water from the problem wells by blending it with water from a well with extremely low nitrate levels. This will ensure a reliable future supply and should prevent future unacceptable nitrate concentrations.

### When you will know this problem is solved


When nitrates are fully reduced, customers will be notified. If nitrates continue to be high, customers will be notified at least every three months.

### High nitrate levels only impact infants

Desert Hills area Arizona American Water customers should not give water to infants below the age of six months. Infants below the age of six months who drink water containing nitrates in excess of standards could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome. Blue baby syndrome is indicated by blueness of the skin. Symptoms in infants can develop rapidly with health deteriorating over a period of days. If symptoms occur, seek medical attention immediately. Adults and children older than six months process nitrates differently than infants and may not be affected.

In a recent routine sampling, water sample results received on February 13, 2004, showed that nitrates levels in the area were 12 mg/l. This is above the nitrate standard or maximum contaminant level (MCL) of 10 mg/l. Nitrates in drinking water are a serious concern for infants less than six months old.

Desert Hills area customers of Arizona American Water should not give water to infants below the age of six months. Infants below the age of six months who drink water containing nitrates in excess of the MCL could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome. Blue baby syndrome is indicated by blueness of the skin.
