Pursuant to A.C.C. Decision No. 66028, UniSource Energy Services (“UES”) files this progress report on the negotiations to restructure the Pinnacle West Capital Corporation (“PWCC”) Power Supply Agreement (“PSA”).

As stated in the February status report, UES was in the process of finalizing an RFP to be released in mid-February. PWCC and UES had agreed that such an RFP could provide alternative solutions for restructuring the PSA. This RFP was released on February 16, 2004. The link below provides access to the website set up by UES that contains all of the RFP documents and information:

On March 11, 2004, UES received proposals from 9 bidders. UES is currently in the process of analyzing these proposals. This analysis will take approximately two weeks. UES plans on meeting again with PWCC in late March to discuss the RFP results and to determine the course of action to be taken in furthering the renegotiation of the PSA. UES will provide a confidential summary of the bid analysis, as well as a summary of the PWCC meeting, to ACC Staff on April 2, 2004.
