**WITHDRAWAL OF QWEST CORPORATION'S UPDATED
STATEMENT OF GENERALLY AVAILABLE
TERMS AND CONDITIONS**

On February 27, 2004, Qwest Corporation ("Qwest") filed its Notice of Updated Statement of Generally Available Terms and Conditions ("Updated SGAT") in the above captioned docket. Qwest now withdraws its Updated SGAT, for the reasons stated below.

The Updated SGAT reflected changes made by Qwest in response to the decision of the Federal Communications Commission in its Report and Order and Order on Remand and Further Notice of Proposed Rulemaking, *Review of the Section 251 Unbundling Obligations of Incumbent Local Exchange Carriers*, CC

Docket Nos. 01-338 et al., FCC 03-227, 18 FCC Rcd 16978 (Aug. 21, 2003) (the “Triennial Review Order”). Qwest prepared changes to its SGAT based upon the Triennial Review Order, and filed its Updated SGAT on February 27, 2004.

The Triennial Review Order was appealed by a number of parties, and the case was heard by the United States Court of Appeals for the District of Columbia. On March 2, 2004 the Court decided United States Telecom Association, Petitioner v. Federal Communications Commission and United States of America, On Petitions for Writ of Mandamus and for Review of an Order of the Federal Communications Commission, case No. 00-1012 (“DC Circuit Court of Appeals Triennial Review Decision”). The Court vacated the Triennial Review Order in part and remanded it in part. The Court of Appeals stated that its vacating of the Triennial Review Order would become effective on the earlier of 60-days from the date of the Opinion or the denial of an application for rehearing. Qwest has not yet been able to determine how the Court’s action affects the SGAT.

In light of the developments described above, Qwest hereby withdraws its Notice of Updated Statement of Generally Available Terms and Conditions and the Updated Statement of Generally Available Terms and Conditions which were

filed on February 27, 2004, leaving the August 29, 2003 SGAT (14th Revision) in effect.


