PROCEDURAL ORDER

BY THE COMMISSION:

On May 28, 2003, Ajo Improvement Company ("AIC" or "Company") filed with the Arizona Corporation Commission ("Commission") a rate application.

The Commission granted intervention to Arizona Water Company ("AWC") on September 14, 2003.

By Procedural Order dated August 11, 2003, the parties were ordered to file surrebuttal testimony and exhibits on or before March 12, 2004.

On March 11, 2004, AWC filed a Motion requesting that the date for surrebuttal testimony and exhibits be extended until March 17, 2003, because its witness has had to attend to a death in the family and is unable to meet the deadline. AWC states that it has contacted all other parties, who do not object to the extension as long as AWC agrees to serve its testimony and exhibits by hand-delivery to AIC's expert.

AWC's request is reasonable and should be granted.

IT IS THEREFORE ORDERED that the deadline for filing surrebuttal testimony and exhibits shall be extended to March 17, 2004, as agreed to by the parties.

IT IS FURHTER ORDERED that all other provisions of the August 11, 2003 Procedural Order shall remain unchanged.
