

**PROCEDURAL ORDER**

13 **BY THE COMMISSION:**

14 On March 24, 2004, the Securities Division ("Division") of the Arizona Corporation  
15 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to  
16 Cease and Desist, for Restitution, for Administrative Penalties, and For Other Affirmative Action  
17 ("Notice") against Mee Diamond & Jewelry, Inc. and Christopher Mee ("Respondents") in which the  
18 Division alleged that Respondent have engaged in acts, practices, and transactions that constitute  
19 violations of the Arizona Securities Act ("Act").

20 On April 2, 2004, Respondents, through their attorney, filed a Notice of Appearance and  
21 Request for Hearing.

22 Accordingly, a pre-hearing conference should be set to address the Division's and  
23 Respondents' filings.

24 IT IS THEREFORE ORDERED that a pre-hearing conference shall take place on May 24,  
25 2004 at 9:00 a.m. at the Commission's office, 1200 W. Washington, Phoenix, Arizona.

26 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized  
27 Communications) applies to this proceeding as the matter is now set for public hearing.


