PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 On March 10, 2004, J. D. Bristow ("Complainant") filed a Complaint with the Arizona
11 Corporation Commission ("Commission") against UNS Electric, Inc. ("Respondent").

12 On March 11, 2004, Docket Control sent a letter to the Respondent indicating that an Answer
13 to the Complaint was required to be filed within 20 days.

14 On April 1, 2004, UNS filed an Answer and Motion to Dismiss.

15 IT IS THEREFORE ORDERED that the Complainant shall file a Response to the
16 Respondent's Motion to Dismiss by no later than April 26, 2004. Pursuant to Commission Rules, an
17 original and 13 copies of the Complainant's Response shall be filed with the Commission's Docket
18 Control Division. The Complainant shall also serve copies of his Response on the Respondent's
19 counsel and legal counsel for the Commission's Staff.

20 IT IS FURTHER ORDERED that, as part of his Response, the Complainant shall indicate
21 whether he wishes to have this matter decided solely on the pleadings submitted in this matter or
22 whether he seeks a formal hearing before an Administrative Law Judge at the Commission's offices
23 at 1200 West Washington, Phoenix, Arizona 85007.


