QWEST CORPORATION'S REQUEST FOR  
PARTIAL WAIVER FROM ITS EXCHANGE  
AND NETWORK SERVICES PRICE CAP  
TARIFF

16 Qwest Corporation ("Qwest") hereby submits this request for a partial waiver from its  
17 existing Exchange and Network Services Price Cap tariff in order to accommodate AT&T's recent  
18 request to install thirty-five (35) residential lines into a business address in order to run a UNE-P  
19 test in Arizona.

20 Section 5.2.A.3(c) classifies residential service based on two criteria: 1) that the service is  
21 furnished to a location primarily used for domestic purposes; and 2) when the directory listing is  
22 a residential one. For purposes of the UNE-P test, neither of these criteria is met. Approval of  
23 this limited waiver request will allow Qwest to provide AT&T with the tools necessary to  
24 conduct the UNE-P testing in an efficient manner pursuant to Commission Decision No. 60308  
(July 31, 1997), and is therefore in the public interest.


