16 and part of the surrounding area in Pima County.

17 2. AWC purchases water from Ajo Improvement Company that it uses to serve
18 customers in its Ajo system. For that reason, AWC is directly and substantially affected by this
19 proceeding. Granting AWC intervention will not unduly broaden the issues presented by the
20 Application and, therefore, AWC is entitled to intervention pursuant to A.A.C. R14-3-105.

21 WHEREFORE, Arizona Water Company respectfully requests that it be granted
22 intervention in the above-referenced matter.
