PROCEDURAL ORDER

On June 5, 2003, Roger and Darlene Chantel ("Complainants") filed with the Arizona Corporation Commission ("Commission") a complaint against Mohave Electric Cooperative ("Mohave") alleging that Mohave has violated several rules and regulations of the Commission.

On July 2, 2003, Mohave filed a request for an extension of time to file its response.

On July 14, 2003, Mohave filed a response to the complaint and a Motion to Dismiss. Consequently, this matter should be set for hearing.


