

1 On January 29, 2004, counsel for The Phone Company of Arizona, LLP (the
2 "Partnership"), filed a proposed settlement in these consolidated dockets for consideration by the
3 parties. In connection with the filing, the Partnership requested a two-week continuance of the
4 hearing date previously scheduled for February 2, 2004, so that the parties might have an
5 opportunity to work on a settlement agreement. The hearing date was rescheduled for February
6 24, 2004, and the administrative law judge requested that the parties file any completed
7 settlement agreement by February 17, 2004.

9 Utilities Division Staff and respondents Partnership, David Johnson ("Johnson") and
10 Frank Tricamo ("Tricamo") believe they will be able to complete a settlement agreement that will
11 result in the dismissal of the Partnership, Johnson and Tricamo from the case. However, the
12 parties believe they will need additional time to complete the agreement. Thus, counsel
13 undersigned requests until Friday, February 20, 2004, to file a settlement agreement in this docket
14 pertaining to the Partnership, Johnson and Tricamo. Counsel for Utilities Division Staff has
15 advised counsel undersigned that Staff does not oppose this request.
