PUBLIC NOTICE OF AN APPLICATION
FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY
BY THE LINKS AT COYOTE WASH UTILITIES, L.L.C.

The Links at Coyote Wash Utilities, L.L.C. has filed with the Arizona Corporation Commission ("Commission") an application for authority to provide Sewer Service to an area in which records indicate that you are a property owner. If the application is granted, The Links at Coyote Wash Utilities, L.L.C. would be the exclusive provider of the sewer service to the proposed area. The Links at Coyote Wash Utilities, L.L.C. will be required by the Commission to provide this service under the rates and charges and terms and conditions established by the Commission. The granting of the application would not necessarily prohibit an individual from providing service to themselves from individually owned facilities on their property. The application is available for inspection during regular business hours at the offices of the Commission in Phoenix at 1200 West Washington Street and in Yuma at The Links at Coyote Wash Utilities, L.L.C. at 4400 E. Highway 80 or the office of it's attorney, Joshua J. Meyer at 11593 S. Fortuna Rd.

The Commission will hold a hearing on this matter. As a property owner you may have the right to intervene in the proceeding. If you do not want to intervene, you may appear at the hearing and make a statement on your own behalf. You may contact the Commission at the address and telephone number listed below for the date and time of the hearing and for more information on intervention. You may not receive any further notice of the proceeding unless requested by you.
