PROCEDURAL ORDER

**BY THE COMMISSION:**

On October 6, 2003, Mountain Glen Water Service, Inc. ("Company" or "Applicant") filed with the Arizona Corporation Commission ("Commission") an application for a permanent rate increase in Docket No. W-03875A-03-0737.

On November 5, 2003, pursuant to A.A.C. R14-2-103, the Commission's Utilities Division ("Staff") issued a notice of sufficiency which classified the Company as a Class D utility which required the Commission to issue a final order on the rate application within 180 days from the date of sufficiency or May 3, 2004.

On December 4, 2003, Applicant filed with the Commission an application requesting approval of financing to purchase arsenic removal equipment in Docket No. W-03875A-03-0870.

On January 13, 2004, Staff filed a Motion to Consolidate ("Motion") the above-captioned proceedings and requested a 45 day extension of the rate case time-frame in order to consider additional data for both cases. Attached to Staff's Motion was a letter from the Company agreeing to Staff's Motion to extend the time-frame by 45 days.

Accordingly, Staff's Motion should be granted and the time-frame extended by 45 days for a final order in the consolidated proceeding to be issued by June 17, 2004. Further, with the extension, the Staff Report, with respect to consolidated proceeding, should be filed by March 4, 2004.

IT IS THEREFORE ORDERED that Staff's Motion is hereby granted.

1 IT IS FURTHER ORDERED that the above-captioned proceedings shall be consolidated and  
2 the time-frame extended for 45 days with a final order to be issued by the Commission by June 17,  
3 2004.

4 IT IS FURTHER ORDERED that the Staff Report in the consolidated proceeding shall be  
5 filed by March 4, 2004.


