We, the undersigned residents and clients of the Mountain Glen Water Service hereby give notice to the ARIZONA CORPORATION COMMISSION that the increased rate adjustment ask for by Mountain Glen Water is NOT acceptable. In 2000 they were given a rate increase and now again wish another increase of apx 29%. The quality and service has NOT changed since the Commission took the water company away from George Papa. The Mountain Glen Water Service refuses to set up a payment drop at their place of business (home) for hand delivered payments, thereby causing a large percentage of the disconnects.

In addition, due to the Rodeo/Chediski Wildfire and the drought in the forested areas homeowners are watering their trees and shrubs more in an attempt to save their greenery. Water bills are very high now with the increase landowners will be forced to stop this rescue effort.
