Arizona Telephone Company ("ATC"), by and through its counsel undersigned, hereby moves the Arizona Corporation Commission for leave to intervene in the above-captioned proceeding pursuant to A.A.C. R14-3-105 and the Administrative Law Judge's Procedural Order dated July 11, 2003. This motion is supported by the following facts and information:

1. On May 19, 2003, ALLTEL Communications, Inc., filed an application (the "Application") for designation as an Eligible Telecommunications Carrier ("ETC") for federal universal service funding throughout ALLTEL's licensed service area in the State of Arizona. In addition, ALLTEL requested that the affected rural local exchange carrier ("LEC") service areas be redefined.

2. According to the Application, the affected rural LECs include Arizona Telephone Company, CenturyTel of the Southwest, Midvale Telephone Exchange, Navajo Communications Company-Arizona, South Central Utah Telephone Association and Table Top Telephone Company.
