Dear Marc:

I spoke with the counsel for the Mutual Benefits Corporation ("MBC") receiver this morning. He confirmed what I had heard from others that the Judge had ruled against MBC at the conclusion of the first stage of the preliminary injunction proceeding. I have not seen the decision, but I understand he also agreed that the company can immediately appeal his decision as it is inconsistent with *Life Partners*.

The evidentiary portion of the Application for a Preliminary Injunction began yesterday. It has been set for three (3) days of hearing, but the receiver's counsel I spoke with, Marc Cooper, believes it could take a couple of weeks before the magistrate, who is hearing the matter, makes a recommendation to the District Court Judge.

I will keep you posted. If you need me to obtain any additional information regarding the MBC matter, please let me know.

It is my recollection that at the recent pre-hearing conference in the *Yucatan* matter, you indicated you would issue a Procedural Order regarding the date by which the Securities Division is to provide a Witness and Exhibit List. Do you still intend to issue a Procedural Order on that issue?


