PROCEDURAL ORDER

BY THE COMMISSION:

On June 4, 2004, AJF Custom Homes, LLC ("AJF") filed a Formal Complaint and Motion for Expedited Hearing alleging that Desert Hills Water Company ("Desert Hills") is unjustifiably refusing to serve five properties owned by AJF and located within Desert Hills certificated service area and that the pending sale of two of these properties necessitates an expedited hearing in this matter.

This matter having previously been referred to and decided by mediation at the Arizona Corporation Commission ("Commission"), a pre-hearing conference should be scheduled to address the issues raised in the Complaint and the emergency nature of such issues.

IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on **June 23, 2004 at 10:00 a.m.** at the Commission's offices at 1200 West Washington, Phoenix, Arizona.

IT IS FURTHER ORDERED that the parties shall appear with counsel.


