PROCEDURAL ORDER

BY THE COMMISSION:

On March 10, 2004, Red Rock Utilities, LLC ("Red Rock" or the "Company") filed an application with the Arizona Corporation Commission ("Commission") for approval of a Certificate of Convenience and Necessity ("CC&N" or "Certificate") to provide water and wastewater service in Pinal County, Arizona.

On April 8, 2004, Commission Utility Division Staff ("Staff") docketed notification to the Company that its application did not meet the sufficiency requirements of A.A.C. R14-2-502.

Red Rock provided additional materials related to the application on April 1, 12, 20 and 26, 2004.

On June 2, 2004, Staff docketed notification to the Company that its application met the sufficiency requirements of A.A.C. R14-2-502.

Accordingly, the matter should be set for hearing.

IT IS THEREFORE ORDERED that the hearing in the above-captioned matter shall be held on **September 2, 2004, at 10:00 a.m.** or as soon thereafter as is practical, at the Commission's offices, **Room 222**, 400 West Congress St., Tucson, Arizona 85701.

IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105, except that all motions to intervene must be filed on or before **August 16, 2004**.

IT IS FURTHER ORDERED that Applicant shall serve public notice of the hearing in this matter, in the following form and style:

3 The Commission does not discriminate on the basis of disability in admission to

7 IT IS FURTHER ORDERED that Company shall mail to any customers and all the property
8 owners in the proposed service area a copy of this notice by first-class U.S. Mail, to begin as soon as
9 possible and to be completed on or before **July 16, 2004**.

10 IT IS FURTHER ORDERED that Company shall file certifications of mailing as soon as
11 practicable after the mailing has been completed.

12 IT IS FURTHER ORDERED that notice shall be deemed complete upon mailing,
13 notwithstanding the failure of an individual customer to read or receive the notice.


14 IT IS FURTHER ORDERED that Staff shall file its Staff Report by **August 13, 2004**.

15 IT IS FURTHER ORDERED that responses by the Company, if any, to Staff's Report shall
16 be filed no later than **August 27, 2004**.

17 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
18 Communications) applies to this proceeding as the matter is now set for public hearing.

19 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
20 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


