I understand I am NOT a party to the settlement agreement between Pine Water Co., PSWID and Mr Brenninger -- However the matter of Three New wells Pine water Co. were to drill in Strawberry has been omitted from the agreement. The following is of extreme concern to Me as a customer of Pine Water co. as well as an intervenor to the subject Rate Case Hearing :

1) At the hearing Pine Water Co. stated they were going to be drilling the three wells beginning June, 2004.

2) In the teleconference that took place Tuesday, March 23, 2004 @ 11:10 AM - in My written notes I asked the question about the three wells Pine Water Co. were to drill in Strawberry and the Response from Mr. Shapiro was " They are still scheduled to be drilled "

There is no requirement in the Written agreement OR " The Order " dated May, 28, 2004 that this HAPPEN. With the ongoing water shortage in the Community I feel it is extremely important that these wells MUST be drilled. Per written testimony by Mr. Hardcastle -- They were originally scheduled to be drilled April, 2003. For whatever reason that DID NOT happen and the drilling date was moved to June, 2004. It is absolutely imperative these wells be drilled and I respectfully ask the Commissioners for assistance in this matter.
