

On Thursday, April 15, 2004, the Arizona Corporation Commission

("Commission") met in open meeting to discuss the recommended opinion and order in

the above-referenced dockets, and to discuss a proposed Settlement Agreement filed on April 14, 2004. At the open meeting Commissioner Gleason suggested that parties to the Settlement Agreement invite all Arizona competitive local exchange carriers ("CLECs") to a meeting to discuss the proposed settlement in advance of the open meeting set for April 21, 2004. CLEC parties and Qwest agreed that such a meeting would be helpful and sent out notice regarding the meeting on Monday, April 19, 2004. The meeting was held via telephone conference call at 3:00 p.m. on Tuesday, April 20, 2004 and lasted approximately one hour.
