PROCEDURAL ORDER

BY THE COMMISSION:

On March 30, 2004, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against H. Jon Kunowski, Precision Model & Design ("PMD"), Air Lase, Inc. ("ALI") and American Innovative Research, Inc. ("AIR") (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock.

Respondent, Kunowski was duly served with a copy of the T.O. and the Notice.

On April 23, 2004, Respondent Kunowski filed a request for a hearing.

Accordingly, a pre-hearing conference should be held on the allegations contained in the T.O. and Notice.


