PROCEDURAL ORDER

BY THE COMMISSION:

On March 4, 2004, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist and Notice of Opportunity ("Notice") against Multimedia Technology Ventures, Ltd., a/k/a MMTV, Ltd., Biltmore Group, Inc., Global Trek Xploration Corp. ("GTX"), Chris and Jane Doe Corbett, Graham and Jane Doe Inch and C. Ronald and Jane Doe Paxon ("Respondents") in which the Division alleged that

1 Respondent have engaged in acts, practices, and transactions that constitute violations of the Arizona
2 Securities Act ("Act").

3 On April 19, 2004, Multimedia Technology Ventures, Ltd., Biltmore Group, Inc., Graham and
4 Jane Doe Inch, and C. Ronald and Jane Doe Paxon, through their attorney Barry D. Halpern, filed a
5 Request for Hearing.

6 On April 23, 2004, by Procedural Order, this matter was set for a pre-hearing conference on
7 May 3, 2004.

8 On April 26, 2004, Global Trek Xploration Corp., through their attorney Douglas F. Behm,
9 filed a Notice of Appearance and Request for Hearing.

10 On May 3, 2004, the pre-hearing conference was held as scheduled. The Division appeared
11 with the assistance of counsel. GTX appeared and was represented by counsel. Chris and Jane Doe
12 Corbett failed to appear, but the attorney for the Division indicated that the mailing address for the
13 Corbetts was incorrect in the service list attached to the Notice. Therefore, Chris and Jane Doe
14 Corbett have not been properly served with the Complaint in this matter. The remaining respondents
15 and their attorney did not appear. The attorney for the Division avowed that she had talked to the
16 attorney representing the remaining respondents, who agreed that this matter should be continued as
17 the parties were negotiating a settlement in this matter.

18 Accordingly, another pre-hearing conference should be scheduled to address the issues raised
19 in the Notice, the presentation of evidence, the scheduling of discovery timelines and to set a hearing
20 date.

21 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on August 18,
22 2004 at 9:00 a.m. at the Commission's offices, 1200 West Washington, Phoenix, Arizona.

23 IT IS FURTHER ORDERED that the temporary order to cease and desist in this matter is still
24 in effect and that the applicable time limits in this matter are waived.

25 IT IS FURTHER ORDERED that the Division shall attempt to perfect notice of this matter to
26 Chris and Jane Doe Corbett.

27 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 – Unauthorized
28 Communications) is still in effect.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive
2 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.


