BY THE COMMISSION:

On February 25, 2004, Qwest Corporation ("Qwest") filed an Application for Rehearing and an Immediate Stay of Decision No. 66772. Attached to that Application was the Affidavit of Harry M. Shooshan III.

On April 16, 2004, Arizona Corporation Commission ("Commission") Utilities Division Staff ("Staff") filed a Motion to Strike Affidavit of Harry M. Shooshan III.
