PROCEDURAL ORDER

BY THE COMMISSION:

On February 25, 2004, Qwest Corporation ("Qwest") filed an Application for Rehearing and an Immediate Stay of Decision No. 66772. Attached to that Application was the Affidavit of Harry M. Shooshan III.

On April 16, 2004, Arizona Corporation Commission ("Commission") Utilities Division Staff ("Staff") filed a Motion to Strike Affidavit of Harry M. Shooshan III.

On April 26, 2004, Qwest filed a Response to Staff's Motion.

By Procedural Order dated May 5, 2004, the Motion was set for oral argument on May 10, 2004.

On May 6, 2004, Qwest and Staff filed a Joint Notice of Withdrawal. Qwest is withdrawing the Affidavit of Harry Shooshan III and its Response to Staff's Motion, and Staff is withdrawing its Motion.

IT IS THEREFORE ORDERED that the procedural conference for oral argument on Staff's Motion to Strike is vacated.




