PROCEDURAL ORDER

BY THE COMMISSION:

On January 21, 2003, Katherine Resort Water Company ("KRWC" or "Applicant") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase.

On February 21, 2003, the Commission's Utilities Division ("Staff") filed a letter informing KRWC that its application did not meet the sufficiency requirements as outlined in A.A.C. R14-2-103.

On December 5, 2003, KRWC and Staff were each ordered to make a filing updating this docket in a Procedural Order.

On December 19, 2003, Mr. Ed Schuetz, on behalf of KRWC, filed a response to the December 5, 2003 Procedural Order. Mr. Schuetz stated that KRWC had provided Staff with the requested information to make its application sufficient in March, 2003. Mr. Schuetz stated that KRWC has not heard anything from Staff since he sent those materials.

On February 9, 2004, Staff docketed a response to the December 5, 2003 Procedural Order. Staff stated that due to the poor condition of KRWC's accounting records, Staff sent KRWC a letter of deficiency on February 21, 2003, that identified the needed corrections to KRWC's filing. However, Staff stated in spite of the deficiencies in the filing, sufficient information was available to process the case as long as Staff did not face a time-clock limitation.

On May 7, 2004, Staff filed its Staff Report in this matter.

IT IS THEREFORE ORDERED that based upon Katherine Resort Water Company's failure to correct the deficiencies of its application, the time-clock for processing this application is hereby

1 extended.

2 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
3 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
