

1. Arizona Dialtone, Inc. is a telecommunications company certified to provide local exchange carrier telecommunications services in Arizona.

2. Arizona Dialtone, Inc. is a reseller LEC and as such, resells Qwest's LEC services to the public pursuant to an Interconnection Agreement between Arizona Dialtone, Inc. and Qwest. Under its Interconnection Agreement, Arizona Dialtone, Inc. purchases the LEC services from Qwest through both wholesale and unbundled network element pricing.

3. Arizona Dialtone, Inc. will be directly and substantially affected by the decisions made in this case regarding Qwest's pricing of telecommunications services.

4. Arizona Dialtone, Inc.'s participation in this proceeding will not unduly burden the nature or scope of the Commission's inquiry.
