BY THE COMMISSION:

On April 30, 2004, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against HCH Enterprises, L.L.C. ("HCH"), Helen C. and John Doe Hartze and Mark and Jane Doe Kesler (collectively "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

The Respondents were duly served with a copy of the Notice.

On May 10, 2004, a request for hearing was filed for HCH and Helen C. Hartze.

On May 18, 2004, a request for hearing was filed for Mark Kesler, an unmarried man.


