
The Securities Division ("Division"), by and through counsel undersigned, moves to stay the above-entitled action and to vacate the pre-hearing conference set for 2:00 p.m. on June 2, 2004. On May 24, 2004, the Arizona Corporation Commission ("Commission") filed an action in the Arizona Superior Court, Maricopa County, Civil Action No. CV2004-010042, naming the respondents in this matter as defendants, and seeking a temporary restraining order, preliminary and permanent injunctive relief, and sanctions for contempt of the Commission's Temporary Order to Cease and Desist previously served upon respondents in this matter. The Court issued a Temporary Restraining Order Without Notice on May 24, 2004; that Order was served on the respondents the same day, together with copies of the Verified Complaint and all other motions and

1 pleadings in that matter. A return hearing on the Commission's Application for Temporary  
2 Injunction was set for June 2 at 10:00 a.m. before Judge Rebecca Albrecht.

3 As a result of the superior court proceedings against the same respondents, the Division  
4 requests the Administrative Law Judge to order that the administrative proceeding be stayed  
5 pending resolution of the superior court proceeding. The Division further requests the  
6 Administrative Law Judge to cancel the pre-hearing conference set for June 2, 2004, at 2:00 p.m.


