**ORDER**

**BY THE COMMISSION:**

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

**FINDINGS OF FACT**

1. On August 6, 2001, in Decision No. 63931, the Commission granted to El Paso Global Networks Company ("El Paso Global" or "Applicant") a Certificate of Convenience and Necessity ("Certificate" or "CC&N") authorizing it to provide competitive facilities-based and resold local exchange and exchange access telecommunications services in Arizona.

2. On March 1, 2004, Applicant filed with the Commission an application to cancel its Certificate. The application stated that Applicant never provided telecommunications services in Arizona and has no customers.

3. On March 29, 2004, the Commission's Utilities Division ("Staff") filed a Staff Report in this matter.

4. In the Staff Report, Staff verified that Applicant does not service any Arizona customers and is no longer doing business in Arizona. Staff has indicated there are no open complaints or inquiries concerning El Paso Global. In addition, Staff stated that there are numerous other carriers offering services similar to Applicant's in Arizona.



1 IT IS FURTHER ORDERED that El Paso Global Networks Company is no longer authorized  
2 to provide telecommunications services in Arizona and therefore is no longer subject to the  
3 requirements of Decision No. 63931.

4 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
