18 2. That Motion stated as the basis for requesting Consolidation the fact that neither
19 Application had, at that time, been declared "Sufficient" by the Staff, and therefore the
20 Applications could most efficiently and effectively be processed simultaneously.

21 3. Counsel for Beardsley was not aware that the Commission Staff had issued the Letter
22 of Sufficiency in Docket No. W-02074A-04-0241 on April 29, 2004.
