**NOTICE OF APPLICATION BY WINSTAR COMMUNICATIONS OF ARIZONA, LLC TO DISCONTINUE CERTAIN TELECOMMUNICATIONS SERVICES**

(Docket No. T-03670A-04-0317) WinStar Communications of Arizona, LLC ("WinStar" or "Applicant") has filed with the Arizona Corporation Commission ("Commission") an application to discontinue: (i) the provision of local and interexchange services to commercial customers in Arizona and (ii) interstate and international long distance, toll free and internet services to commercial customers in Arizona. The Application is available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007, and at Applicants' address located at WinStar Communications of Arizona, LLC, 520 Broad Street, Newark, NJ 07102. Under Commission Rule A.A.C. R14-2-1107, interested parties have thirty (30) days from the publication date of this notice to file objections to the Application, to request a hearing and/or to submit a motion to intervene in the proceeding. If no objections are received, the Commission may grant the Application without a hearing. Persons desiring to intervene must file a written motion to intervene with the Commission and send such motion to the Applicant or its counsel and to all parties of record, and the written motion shall contain, at the minimum, the following:

1. The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.
2. A short statement of the proposed intervenor's interest in the proceeding (e.g. a customer of the company, a shareholder of the company, a competitor, etc.).
3. A statement certifying that a copy of the motion to intervene has been mailed to the Applicant or its counsel and to all parties of record in the case.

A.A.C. R14-3-105 shall govern the granting of motions to intervene. The granting of intervention, among other things, entitles a party to present sworn evidence at the hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any interested person or entity from appearing at a hearing and making a statement on their own behalf or submitting a written statement to the Commission. 
