PROCEDURAL ORDER

BY THE COMMISSION:

On May 1, 2003, Pine Water Company ("Pine Water") filed with the Arizona Corporation Commission ("Commission") an application for a determination of the current fair value of its utility plant and property, a rate increase and for approval of long-term debt.

Evidentiary hearings were held on various days in March 2004. On April 2, 2004, a hearing was held regarding a Settlement Agreement that was negotiated between all but one of the parties.

On May 28, 2004, a Recommended Opinion and Order was issued. Exceptions to the Recommended Order are currently due to be filed by June 7, 2004.

On June 4, 2004, Pine Water filed an Emergency Motion for Extension of Deadline for Filing Exceptions and Waiver of Time-Clock Rules ("Motion"). In its Motion, Pine Water requests an extension for filing Exceptions until June 30, 2004. The Company claims it has requested that consideration of this matter be rescheduled for an Open Meeting in late July or early August 2004 and, as a result, no party will be prejudiced by granting an extension of the Exception deadline. Pine Water also states that it waives any applicable time-clock rules that may apply.

IT IS THEREFORE ORDERED that the deadline for filing Exceptions to the Recommended Opinion and Order shall be extended until June 30, 2004.


