PROCEDURAL ORDER

**BY THE COMMISSION:**

On July 1, 2003, Qwest Corporation ("Qwest") filed the Qwest Renewed Price Regulation Plan in accordance with the provisions of the Second Revised Settlement Agreement approved on March 30, 2001.

By Procedural Order dated November 17, 2003, the Commission determined that Phase I of the Access Charge Docket, which addresses Qwest's access charges, should be considered in conjunction with the Price Cap Plan Docket.

On May 20, 2004, and May 28, 2004, respectively, Arizona Dialtone, Inc. ("ADI") and Time Warner Telecom of Arizona, LLC ("TWTA") filed Applications to Intervene in the above-captioned matters.

No party objected in either Application.

IT IS THEREFORE ORDERED that ADI's and TWTA Applications To Intervene are granted.


