Dear Ms. Vandenberg:

During the Administrative Hearing on the above referenced Application, my witness was mistaken about certain facts. If a hook-up is defined as when a permit is received to connect to the system (which usually occurs when construction on a home or a lot is about to begin), then instead of the approximately 30 hook-ups that Mr. Clearly estimated currently exist, there are 68. Of that 68, however, 15 are for houses still under construction, approximately 30 are for RV lots that will not be used until the fall, and 6 are the model homes. Therefore, there are only about 5 customers actually using the facilities.

To allow the construction of homes currently planned, the applicant is requesting that it be allowed 20 additional hook-ups, thus bringing the maximum total number of hook-ups before a CC&N is issued to 88.

I published the notice required by the Administrative Law Judge on May 27, 2004, I have obtained a copy of the Aquifer Protect Permit listing the Applicant as the permittee, and I am waiting for an opinion from the attorney for the Town of Wellton that will evidence the Applicant's right to use the public right-of-way for its collection system. As a result, I believe we will be back "on-track" for an approval by the Commission.


