Dear Mr. Dean:

On November 3, 1998, OLS, Inc. filed an application for a CC&N to provide resold intrastate toll telecommunications in the State of Arizona. The Applicant is required to publish legal notice of the application in all counties where services will be provided no later than 20 days after the application is filed. The Applicant must file with the Commission copies of the affidavits of publication for each newspaper in which public notice in this matter was published. The Arizona Republic is the only singular publication, which is sufficient for statewide publishing of legal notice. The Arizona Business Gazette is only sufficient for Maricopa County.

Additionally, in order for Staff to continue with its review of this application, the following information must be submitted:

- A. Include a copy of your Company's most recent balance sheet, income statement, audit report (if audited), and all related notes to these financial statements.
- B. If the balance sheets you submit do not have retained earnings accounts, please provide this account information on a separate sheet.
- C. Will your customers be able to access alternative toll service providers or resellers via 1+ or 101XXXX access, if your system becomes non-operational?
- D. Is your company currently reselling telecommunications service in Arizona?
- E. List the names of all owners, partners, limited liability company managers, or corporation officers and directors (specify), and indicate percentages of ownership.



This information must be received by Docket Control within 30 days of the date of this letter. Please mail an original plus 10 copies to: Docket Control, Arizona Corporation Commission, 1200 W. Washington Street, Phoenix, AZ 85007-2927. If no response is received within 60 days of the date of this letter, Staff will recommend that the application be terminated. If the application is terminated, the Applicant cannot provide the same telecommunications services in Arizona for which it is currently applying, until such time as a new application is filed with and approved by the Commission.
