NOTIFICATION OF INTERVENTION

10 On May 1, 2000, Mountain Glen Water Service, Inc. ("Applicant") filed an application for
11 approval of a Certificate of Convenience and Necessity ("Certificate") to provide water service for
12 property located in Navajo County, Arizona.

13 On June 9, 2000, a Procedural Order was issued by the Commission setting the matter for
14 hearing on September 20, 2000 at 1:00 p.m.

15 On July 6, 2000, Ms. Deborah Hilton ("Ms. Hilton") filed a Motion to Intervene ("Motion"),
16 stating that she is a landowner in the proposed Certificate area. Ms. Hilton also stated she does not
17 desire the Applicant to provide her with water service.

18 Applicant does not oppose Ms. Hilton's intervention.

19 Ms. Hilton is directly and substantially affected by the proceeding, and her participation in the
20 proceeding will not unduly broaden the issues raised.

21 IT IS THEREFORE ORDERED that the request to intervene by Ms. Deborah Hilton is
22 hereby granted.


