MEMORANDUM OF POINTS AND AUTHORITIES

20 On December 10, 2003 the Commission entered a procedural order in this matter that set  
21 this matter for hearing on February 17, 2004. Since that date, Core Group Consultants LTD, one  
22 of the property owners that requested that AWC file its application in this matter, has asked  
23 AWC to attempt to have the hearing rescheduled to an earlier date. The Staff is the only other  
24 party to this matter; the Staff has informed AWC that it would not object to AWC's Motion to  
25 Expedite.



1 The December 10, 2003 order also directed AWC to provide public notice of the hearing  
2 by publication and mailing. Although the mailing has not yet occurred, the notice of hearing was  
3 published on December 22, 2003 in the Casa Grande Dispatch, a newspaper of general  
4 circulation in the proposed service territory, Staff has suggested to AWC that, in view of the  
5 publication, the February 17, 2004 date could possibly serve as a date for accepting public  
6 comment.

8 WHEREFORE, AWC respectfully requests that the February 17, 2004 hearing in this  
9 matter be rescheduled to an earlier date.
