PROCEDURAL ORDER

BY THE COMMISSION:

On August 12, 2003, Arizona Water company ("AWC" or "Applicant") filed with the Arizona Corporation Commission ("Commission") an application for an extension of its Certificate of Convenience and Necessity ("Certificate") to provide water service in Casa Grande, Pinal County, Arizona.

On November 26, 2003, the staff of the Commission's Utilities Division ("Staff") filed a letter indicating that AWC's application has met the sufficiency requirements as outlined in the Arizona Administrative Code.

On December 10, 2003, a Procedural Order was issued setting this matter for hearing on February 17, 2004 at 10:00 a.m.

On December 23, 2003, AWC filed a Motion to Expedite Hearing, which indicates that notice of the February 17, 2004 hearing has been published and that Staff informed AWC that it has no objection to expediting the hearing.

Staff has filed nothing in support of or in opposition to AWC's Motion to Expedite Hearing.

Based upon the fact that AWC has already published notice of the hearing currently set for February 17, 2004, which sets forth specific dates for intervention, granting the Applicant's Motion would create confusion and place individuals relying upon that information at an unfair disadvantage.

Every effort will, however, be made to expeditiously process the application.


IT IS THEREFORE ORDERED that AWC's Motion to Expedite is denied.


