

In order to resolve in an expeditious manner the issues raised by parties concerning Hewlett-Packard's role as pseudo-CLEC in this case, Commission Staff and its consultant Doherty and Company, Inc. ("DCI"), will be presenting their report(s) on these issues prior to the commencement of the next TAG Meeting in Denver, Colorado on December 13 and 14, 1999. The Commission Staff will arrange to have a conference bridge put in place so that any parties that are unable to attend the December meeting in person, will be able to participate by phone. Staff will notify all parties of the call-in number prior to the meeting next week.

Staff will present its report beginning at 8:00 a.m. and will set aside approximately 1-2 hours for discussion, if necessary. Staff will hand out a copy of its findings and other materials at that time. Staff also intends to set aside time before the start of the meeting on the second day for parties to express any remaining concerns that they may have on this issue. It is Staff's intent to try to work through any remaining concerns at the meeting on December 14, 1999. Staff has asked attorneys from the Department of Justice and the FCC to listen in on the discussion on this issue, since Staff may consult with either or both of these agencies in its attempt to bring closure to this issue.
