Pursuant to A.A.C.R. 14-3-105, SBC Telecom, Inc. ("SBCT") applies for an order granting leave to intervene in the above-captioned docket.

On June 13, 2000, the Arizona Corporation Commission (the "Commission") granted SBCT a Certificate of Convenience and Necessity to provide competitive resold and facilities-based local exchange and inter-exchange telecommunications services. See Docket No. T-03811A-99-0693. On July 25, 2000, the Commission approved the Interconnection Agreement between SBCT and Qwest Communications Corporation, f/k/a, US West Communication, Inc. ("Qwest"). See Docket Nos. T-01051B-00-0266; T-03811A-00-0266, Decision No. 628752.

SBCT's interest as an interconnected competitive telecommunications provider may be directly affected by the issues to be decided in this proceeding and Qwest's compliance with Section 271 of the Telecommunications Act of 1996. Granting SBCT's intervention will not cause the issues in this proceeding to be unduly broadened and may facilitate SBCT's participation in forthcoming Section 271 workshops.
