Dear Sir or Madam:

Teleglobe USA Inc. ("Teleglobe") was granted a Certificate of Convenience and Necessity (CC&N) to provide competitive resold interexchange telecommunications services in Arizona by Decision No. 61126, dated September 16, 1998, in Docket No. T-3473A-97-0684. Teleglobe does not serve any Arizona customers under its Arizona CC&N nor has it accepted any prepaid advances or deposits. Attached is a verification from Charles Tievsky, Assistant General Counsel for Teleglobe, confirming Teleglobe's lack of customers in Arizona.

Teleglobe does not intend to exercise its authority to provide services under its CC&N in the State of Arizona. Consequently, Teleglobe requests that the Commission cancel its CC&N.

Teleglobe further requests a waiver of the A.A.C. R14-2-1107 requirement to provide legal notice and a list of alternative utilities because Teleglobe serves no customers under its Arizona CC&N and no customers are impacted by this request for cancellation.


