PROCEDURAL ORDER

BY THE COMMISSION:

On May 13, 2003, Mount Tipton Water Company, Inc. ("Company") filed the above-captioned rate application with the Arizona Corporation Commission ("Commission").

The Commission's Utilities Division Staff ("Staff") found the application sufficient on September 8, 2003.

By Procedural Order issued September 22, 2003, the above-captioned matter was set for hearing to commence on March 25, 2004.

On November 26, 2003, a letter from the Dolan Springs Chamber of Commerce was filed in this docket requesting that the hearing be held in Dolan Springs. On January 6, 2004, Staff filed a Request for Extension of Time. There was objection to either request. By Procedural Order issued January 21, 2004, the hearing was moved to Dolan Springs; the hearing date was continued to June 9, 2004; and associated procedural deadlines and the timeclock were extended accordingly. Mt. Tipton was ordered to provide notice of the new hearing date and location to its customers by means of an insert in its next regularly scheduled billing. Because the customers have previously been notified of the March 25, 2004 hearing date at the Phoenix location, public comments on this matter will also be taken on March 25, 2004 at 10:00 a.m. in Phoenix.

In addition to the previously scheduled opportunity for public comment at Dolan Springs Community Hall at the commencement of the hearing on June 9, 2004 at 9:00 a.m., Commissioners will be in attendance at an additional public comment session on the evening of March 15, 2004, also at Dolan Springs Community Hall.

1 IT IS THEREFORE ORDERED that an additional public comment meeting on this matter is
2 hereby scheduled to be held on **March 15, 2004, commencing at 6:00 p.m., at Dolan Springs**
3 **Community Hall, 16126 N. Pierce Ferry Road (Intersection of Pierce Ferry Road and**
4 **Edgemont Road), Dolan Springs, Arizona 86441.**

5 IT IS FURTHER ORDERED that Mount Tipton Water Company, Inc. shall notify its
6 customers of this additional opportunity for public comment, including the date and location, by
7 means of an insert in its next regularly scheduled billing.

8 IT IS FURTHER ORDERED that the provisions of the Procedural Order issued January 21,
9 2004 in this matter remain in effect.

10 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
11 Communications) applies to this proceeding and shall remain in effect until the Commission's
12 Decision in this matter is final and non-appealable.

13 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, -or waive
14 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


