Pursuant to Rule 14-3-105 of the Arizona Corporation Commission Rules of Practice and Procedure, Qwest Corporation ("Qwest") applies to intervene in the above-captioned proceeding and states the following:

1 1. Qwest provides wholesale telecommunications and related services, pursuant to
2 an interconnection agreement, to the Phone Company Management Group, LLC, one of the
3 named respondent entities in this proceeding. Upon information and belief, the Phone Company
4 Management Group, working in connection with various other named respondent entities,
5 provide telecommunications service to over 4500 customers in the state of Arizona.

7 2. At present, The Phone Company of Arizona and its related entities owe Qwest
8 more than \$1,000,000 in fees related to services provided pursuant to the interconnection
9 agreement between the companies.

10 3. Qwest will be directly and substantially affected by the issues raised in this
11 docket.

13 because Qwest's participation in this proceeding will not unduly broaden the nature or scope of


