EXTENSION OF TIME**



The one-month extension of time requested by Staff will prejudice Qwest and its efforts to complete collection of approximately \$1.5 million in unpaid charges. Additional delay will continue to leave Qwest without recourse for collecting this unpaid amount, will prevent it from discontinuing service for non-payment, and will further increase the total amount due to Qwest


