4 PCMG has voluntarily surrendered its Certificate of Convenience and Necessity  
5 ("CCN") to the Arizona Corporation Commission ("ACC"), effective April 1, 2003 and has  
6 requested cancellation of its effective tariff effective the same date. See Exhibit A. Having  
7 surrendered its CCN, all of the issues raised in this proceeding have been rendered moot.




Ladies and Gentlemen:

On Systems Technology, LLC, owner of The Phone Company Management Group, LLC, formerly known as LiveWireNet of Arizona, LLC ("PCMG") hereby advises the Arizona Corporation Commission ("Commission") that PCMG is voluntarily surrendering its Certificate of Public Convenience and Necessity ("CCN") granted to it by the Commission in Docket No. T-03889A-00-0393 in Decision No. 63382, issued February 16, 2001, effective upon your receipt of this advice letter.

Accordingly, PCMG will no longer be providing service to local exchange customers in Arizona pursuant to the CCN, effective upon its surrender. PCMG's customers were previously notified by the Staff of the Commission of possible termination of their service on March 21, 2003. PCMG understands that its customers have independently made arrangements to transfer their local exchange service either to Qwest or to another service provider included on the list attached to the Staff's letter notifying the customers of possible termination of service on March 21, 2003.
